THE POWER OF **SITE** VISITS



The last couple of months, TVEA visited sites to connect with new and potential members and touch base with membership. President Edgar Díaz visited sites at lunch and throughout the day with help from TVEA Vice President Underwood (VRMS), High School Area Reps Doug VonSteege (TVHS) and Abby Woelke (GOHS), Elementary Area Reps Jamie Vaugh (HIIA), Student Support Specialist Cynthia Lopez, and Organizational Director Lisa Sisco.

The site visits show that TVEA membership provides advantages. As a union, we support each other in the class or office and in professional and personal growth. TVEA membership grew from 1250 in September to just under 1300 in December. That's 117 new members since summer and climbing towards 95% membership! This growth is a combination of new hires this year and individuals hired last year on a temporary contract. Yes, membership does provide benefits for teachers on temporary and probationary contracts. TVEA is advocating for a change in the way TVUSD staffs classrooms with temporary contracts. Employees make a commitment to the students of TVUSD, TVUSD needs to make a commitment to teachers and hire with probationary contracts and provide them summer pay and benefits.

With the numbers above, TVEA is in the middle of a change in membership. The last 2 years show over 200 members are new to the district and a large percentage in their first 5 years in education. That's 15% of our membership. The site visits provide an opportunity to help connect TVEA with new members to the teaching and learning conditions in the district and how we can continue improving. It also helps TVEA to develop systems to support individuals new in education and develop the next leaders of the organization and the district.

There is a reason TVUSD consistently performs at such high levels, and it is you! As a member, you have the power to advocate and organize to provide feedback not only in TVEA input sessions and governance, but through TVUSD forums such as grade level district meetings, curricular council, Superintendent Council, site LCAP consults and School Site Councils. Your voice is valuable in site and district gatherings to implement what you see happening with your interactions with students. Don't let that power go.

While we have been out to 18 sites, we have 9 to go before we start Bargaining Input sessions at each site in the spring. See you soon!

KNOW YOUR CONTRACT



It is a great time to take inventory on the amount of leave you utilized this year, and how much you have left. From the TVEA contract, you have 10 leave days that are allocated each year, those days accrue to the next year, if left unused.

On your pay warrant, look at the hours available and divide by 7, to give you "by the day" calculation. Now, log on to Aesop and run a report on the leave days you have taken this year.

Every year you are entitled to take 10 days of Personal Business day, as long as it does not connect to a paid holiday. Do not exceed this or you are responsible for the per diem cost of your daily salary. Only Personal Illness allows you to exceed your accrued leave, and you will continue to be paid, minus the rate of a substitute, which is \$142.

You are able to take your leave anytime, without pre approval (Personal Business has exceptions, see above).

Leave does accrue and you can port it to another school district, it is not lost. Consider banking your leave for later in your career to help with family or health emergencies that life may bring. Banked leave is a great resource in times of need. Individuals can use an unlimited amount of medical leave, but the more accrued leave you have, the more fully paid days you will have accessible to you later in your career.

KNOW YOUR RIGHTS

WEINGARTEN RIGHTS

The US Supreme Court has ruled that the National Labor Relations Act gives workers the right to request union representation during investigatory interviews by supervisors, security personnel and other managerial staff. These are called Weingarten Rights.

I REQUEST REPRESENTATION

If you are called to a meeting with management, read the following when the meeting begins. "If this discussion could in any way lead to my being disciplined or terminated, or affect my personal working conditions, I respectfully request that my Association representative be present at the meeting."

You have the right to pause the meeting at any time to request representation.

Bargaining Update

Stipends for Elementary and Middle School - Settled! Look for a joint statement between TVEA/TVUSD on a resolution for the implementation of the stipends for elementary and middle school.

On December 9th, Ad-Hoc groups met with TVUSD to continue discussions for Social Workers and Elementary SDC Case Management. While the title social worker and the type of work is similar at all grade level spans, the requirements and compensation varies greatly between them. This session involved TVEA social workers bringing their experience and knowledge to the table.

Settling the Elementary SDC Case Management MOU is long overdue. Our colleagues working in difficult conditions need access to case management time now! How are they to conduct one-on-one test and complete IEPs with a class of students around them? With one semester completed, how much longer should they wait?

CTA STATE COUNCIL NEW BUSINESS ITEMS

THESE ITEMS ARE VOTED ON BY CTA STATE COUNCIL REPS

1. NBI #: 10/22-13 - CTA will lobby to get legislation passed guaranteeing all teachers get a prep period during the day and that teachers cannot be forced or asked to substitute or do duties during that prep period but instead must volunteer themselves and be paid at least an hourly rate for doing it
2. NBI #: 10/22-16 - That CTA lobby the California State Legislature to pass legislation to change Ed Code to grant an 11th yearly sick leave day to certificated educators who work 11 months
3. NBI #: 10/22-31 - That CTA lobby the California State Legislation to pass legislation to require school districts to accept all years of service in public education when hiring a new teacher.
4. NBI #: 10/22-34 - This body is hereby tasked to examine, study, and draft policy language that reinstates teachers' loss of wages resulting from docked pay imposed by their respective school district payroll department via the use of SB114 between the years of 2020-2022.
5. NBI #: 5/22-10 - CTA will work to pass legislation to ensure that the starting pay in all school districts for all of our members is above the minimum exempt professional salary level for the County they work in with automatic increases each year to ensure that it never drops below that level.

SPECIAL EDUCATION COMMITTEE

NBI 10/22-19 Action: CTA will create a workgroup that will determine the best solutions, such as legislation, for caseload/workload limits, speech-language pathology assistants, and CTA staff training, for alleviating the workload problems that SLPs are facing and addressing the shortage of SLPs.

NBI 5/22-21 Action: CTA shall actively lobby with education-friendly CA legislators to craft and implement changes to the existing CA Ed Code to better reflect CTA policy concerning Special Education Caseload.

LEGISLATIVE AGENDA - SACRAMENTO SCENE

AB 167 - CalSTRS retirees will be justly compensated for benefit reductions that stem from employee and CalSTRS reporting errors.

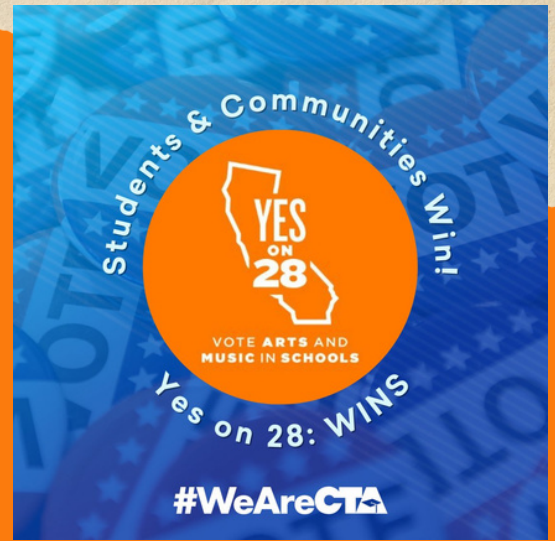
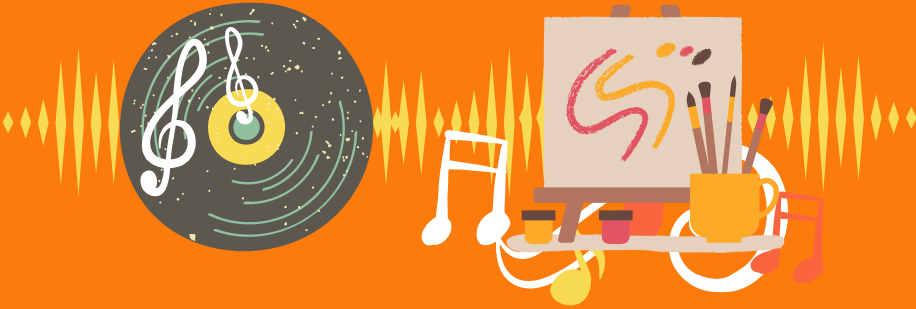
SB 868 - Creates a one-time permanent adjustment applied to the total current benefits that is paid to CalSTRS retirees and beneficiaries of retirees who retired prior to 1999. An added 5% increase to educators who retired in the 90's. 10% increase for retirees from the 80's. 15% for those who retired earlier.

AB2675 - Extend probationary period for certificated educators to up to four years. Did not get a hearing. Died.

SB 70 - Makes kindergarten mandatory beginning with the 2024-2025 school year.

PROP 28 - AB185

Arts, Music and Instructional Material Block Grant



Music to our ears! California voters recognize the critical importance of arts and music programs to student success and overwhelmingly pass Prop. 28! Our students win!

On November 8th Californians overwhelmingly passed Proposition 28, providing an investment in arts education. It is now known as AB 185 or the Arts, Music and Instructional Material Block Grant.

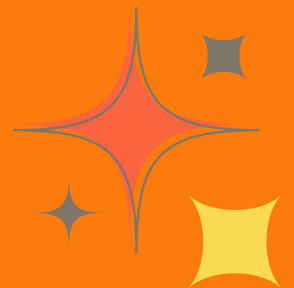
Funds will be distributed according to enrollment, with 70% based on overall enrollment and 30% based on Title 1 enrollment. TVUSD has an allocation of \$16,285,474 for fiscal year 2022-2023. Of the allocation, 80% must be spent on teachers and aides, and the remainder is earmarked for art supplies and materials. The first part of the allocation to be released early 2023.

The advantage to our students is proven in research. Studies show that children that participate in the arts have better attendance in school, higher achievement in academic subjects and help in their social and emotional well-being.

What does that mean for our schools? Now is the time to get involved to shape what implementation looks like in TVUSD. This funding can increase support at the secondary level and dramatically boost VAPA at the elementary level. The funding can provide funding for over 100 teachers! Elementary would need 18 funded positions to house a VAPA teacher at each campus for the year, thus creating a permanent time for classroom teachers to prepare for instruction.

While the Arts, Music and Instructional Materials Block Grant can also be used for other uses, these funds provide TVEA an opportunity to build opportunities for our students.

CTA Scholarships



CTA offers several different educational scholarships to members and their dependents throughout the academic year. Listed below are the major CTA scholarships.

CTA Scholarship For Dependent Children

This program offers up to thirty-five (35) scholarships in the amount of \$5,000 each to dependent children of active, retired or deceased CTA members. The highest scoring applicant is awarded the Ralph J. Flynn Memorial Scholarship.

CTA Scholarship For Members

This program offers up to five (5) scholarships in the amount of \$3,000 to current "active" CTA members completing college coursework. The highest scoring applicant is awarded the Alice Piper American Indian/Alaska Native Memorial Scholarship.

Del A. Weber Scholarship for Dependent Children Attending Continuation High School/Alternative Programs

This program offers one scholarship in the amount of \$5,000 to a dependent child of an "active," retired or deceased CTA member who is attending or attended a continuation high school

LGBTQ+ Safety in Schools Grant and Scholarship Program in Honor of Guy DeRosa

This program provides grants to support projects and presentations that promote understanding and respect for Gay, Lesbian, Bisexual and Transgender persons, in addition to scholarships for members enrolled in a teacher/counseling credential or graduate program who understand the importance of GLBT educators as role models.

Martin Luther King Jr. Memorial Scholarship

This CTA scholarship is given in memory of Dr. Martin Luther King, Jr. to aid members of ethnic minorities in pursuing a college degree, credential or certification for a teaching-related career in public education. Applicant must be an "active" CTA member, Student CTA member or dependent of a CTA member.

CTA César E. Chávez and Dolores Huerta Education Award Program

Through NEA's Learning & Leadership grants, they support the professional development of NEA members by providing grants to Individuals to participate in high-quality professional development like summer institutes, conferences, seminars, travel abroad programs, or action research

Learning & Leadership grants will fund projects between \$1,500 and \$5,000. Grants fund activities for 12 months from the date of the award. Applicants must be teachers, education support professionals, or specialized instructional support personnel and must be current NEA members.
